Fees are charged separately for cryptocurrency trading accounts, cold and hot wallets. Transfer requests from cold wallets will be processed within 3-6 hours Mo - Fr 8am - 3pm CET, excluding bank holidays (of Zug, Switzerland). Requests received after 3pm will be processed next business day. Deliveries into or out of SEBA are only possible to a wallet under the control of the client. Withdrawal fee is charged only once for multiple transfers within one week. Payment fees quoted in CHF are charged in account currency equivalent.
